**SUBJECT:** Selling of electrical energy by KESH sh.a. for the time period 24.12.2019.

Dear Partner,

The Albanian Power Corporation (KESH jsc) intends to sell electrical energy for the date 24.12.2019.

You are invited to submit your offer for purchasing from KESH sh.a. electrical energy as follows:

1. The companies are encouraged to offer total required quantities for the whole period, but offers that submit lower quantities than the total required quantity, will also be accepted. Companies have to offer supply of electrical energy for the whole required period without interruptions and without changed power.
2. The electricity the electrical energy is asked under the following profile selling electricity/continuous supply for Tuesday 24-th of December 2019, 00:00-24:00 (24 hrs), (CET Albanian Local Time).
3. The Bid Evaluation Criteria is the highest unit/price.
4. KESH sh.a. based on the audit recommendations of the Supreme State Audit and in accordance with the events occurring during previous procedures, requires all companies to be represented by only ONE independent entity, which should have unique legal name, unique headquarter, unique legal representatives and all distinguish criteria of an independent commercial company, until a new decision of responsible authorities for "Protection of competition".
5. The parties shall not be entitled to assign any rights under the Contract.
6. KESH sh.a. reserves the right to decline any bid or to accept fully or partially the quantities of electrical energy submitted by the companies or to cancel the selling-purchasing procedure (partly or totally) on its sole discretion.
7. In the unit/price is included the value of fiscal obligations, but is not included the value of VAT. Only for comparison and evaluation reasons, the classification of the offers will be based on the lowest unit/price that does not include the value of VAT.
8. The contract with the foreign companies will be signed based only on the final offer's unit/prices and value of their offer, in which the value of VAT and other fiscal obligations will not be included. The contract with the local companies will be signed with the total value of the final offer (which includes VAT value + the values of all fiscal obligations recognized by the Albanian Legislation).
9. The Seller/KESH jsc will require to the companies to issue bank guarantees, make prepayment or other financial conditions as specified in Article 14.2 of the General Agreement. The non fulfillment of above mentioned financial conditions from the companies will bring disqualification of participant/s.
10. The payment will be on or before the twentieth (20th) day of the calendar month after the last day of the delivery of electricity.
11. KESH j.s.c, requests from all interested companies that will participate in this procedure to submit only **one price for Lot 1.**

12. Other criteria of participation to the purchasing procedure is the submission of legal-financial documentation stipulated in the article 5 of KESH j.s.c Trading Rules, approved by the Minister of Infrastructure and Energy and published at official website: [www.kesh.al](http://www.kesh.al) (except the companies that have submitted this documentation at KESH j.s.c).
13. All offers **must have a validity period until 23 December, 2019, hour 09:00**, Albanian local time. Offers without validity period or with validity period shorter than 23 December 2019, hrs 09:00, Albanian local time, will be automatically disqualified.
- 14. All the offers will be sent only by email and without negotiating phase.**
